



Maryland Lottery® My Lottery Rewards™ Sheetz® Free Gas Giveaway Second-Chance Promotion Drawing Rules

OVERVIEW:

Beginning any time on July 21, 2022 until 11:59:59 PM Eastern Time (“ET”) on August 23, 2022 (“Promotion Period”), players can participate in the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) My Lottery Rewards™ Sheetz® Free Gas Giveaway Second Chance Promotion (“Promotion”) by entering \$10 Mega Millions® tickets purchased at participating Sheetz® locations into My Lottery Rewards™ for a chance to win up to \$1,000 in Sheetz gas cards to be used towards gas purchases at Sheetz, Inc. (“Sheetz®”). Prizes will be awarded in the form of Sheetz Gas Cards (“Cards”, or “Card”). Five (5) drawings will be held throughout the Promotion to select a total of fourteen (14) winners. Twelve (12) winners will be selected to win a Card pre-loaded with \$250 to be used towards gas at Sheetz® locations, and two (2) winners will be selected to win two (2) Cards pre-loaded with \$500 each for a total of \$1,000 in Cards to be used towards gas at Sheetz® locations (“Prize” or “Prizes”). Prizes totaling \$5,000 will be given away in Cards during the Promotion. See below for drawing entry deadlines, drawing dates, number of winners, Prizes, and claiming deadlines.

PRIZE:

Each Card will be pre-loaded with gas credits* for the Prize won, and can only be used towards the purchase of Sheetz® gas. The final Drawing winners will each receive two (2) Cards pre-loaded with \$500 in gas credits for a total of \$1,000. Cards are valid for at least one year from the date winner receives the Card.

*Gas credits have no cash value.

HOW TO ENTER:

To participate, enter at mdlottery.com/sheetz one winning or non-winning Maryland Lottery® Mega Millions® ticket in the amount of \$10 on a single ticket purchased from any participating Sheetz location in Maryland during the Promotion Period (“Ticket” or “Tickets”). Each \$10 Ticket entered equals one (1) entry into the drawing. (A \$10 Ticket equals one (1) entry into the drawing, two \$10 Tickets equals two (2) entries into the drawing, three \$10 Tickets equals three (3) entries into the drawing, etc.) Throughout the Promotion, twelve (12) winners will be drawn to win a \$250 Sheetz® Gas Card, and two (2) winners will be drawn to win \$1,000 in Sheetz® Gas Cards (two (2) \$500 Sheetz® Gas Cards).

Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. For each drawing: Entries must be entered for a specific drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline date (see above) to be eligible for that drawing. (In these Sheetz® Free Gas Giveaway Second Chance Promotion

Drawing Rules ("Rules"), all times are Eastern Time.) A drawing may include any random selection event. These are bonus drawings.

Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once throughout the Promotion. Only Tickets purchased and entered during the Promotion Period are valid entries. For second-chance Drawings, you do not need to keep your original Ticket(s) in order to claim your prize if you win. (Players and winners are sometimes referred to as "you" and "your".) A Ticket may only be used to enter one (1) time.

Winner will receive a W-2G from the Lottery for any Prize over \$600.

Winners will be announced at mdlottery.com/rewards and may be announced elsewhere as well.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of the claiming deadlines. Winners and, if applicable, alternates for each drawing must claim your prize by 4:30 PM on the applicable claiming deadline listed in the chart above. If more than one (1) name is provided on any winning entry, the Lottery will choose which is the winner.

Winners may claim your prize as follows.

For the winners of the \$1,000 Gas Cards Prize:

You must claim your prize in person by 4:30 PM of the claiming deadline date listed in the chart above at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

For winners of the \$250 Gas Card Prize:

This prize will be automatically fulfilled by Scientific Games, LLC and its subcontractors.

For all winners:

- 1) Winner must furnish photo I.D. proof of being at least eighteen (18) years of age. All winners are responsible for all taxes, including income taxes.
- 2) If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations in order for the prize to be awarded to you. If any of those outstanding State Obligations are not paid off within five (5) business days of claiming the prize, then you will be disqualified, and an alternate winner may be selected.
- 3) In the event of a winner's death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize. The Lottery's decision will be final.
- 4) You do not have the option to request or receive a substitute or equivalent prize, including cash, for any prize.
