

# MY LOTTERY REWARDS™ POINTS FOR DRAWINGS® Sizzling Summer Cash State Fair Promotion Drawing Rules

11:59:59 PM ET

DRAWING DATE: Tuesday, August 6, 2024

**POINTS REQUIRED FOR ENTRY:** 75 Draw Points

WINNERS: 10

## **PRIZE DETAILS:**

<u>Prize:</u> Each of the ten (10) winners ("Winners" or individually "Winner") will receive:

- five (5) general admission Maryland State Fair tickets ("Tickets")
- one (1) parking pass for the day of the event, and
- the opportunity to participate in the MD Lottery's Sizzling Summer Cash State Fair Event ("Event") on Saturday, August 31, 2024 to win cash prizes. (Winners must be present at the State Fair Event to win cash prizes.)

#### **Event Prizes:**

- One winner will become the Cash Machine Finalist ("Finalist") and will have 30 seconds inside the Cash Machine to grab and gather as much cash as he/she can.
- Four winners will become Runners-Up and will receive half of the cash amount that the Finalist receives.
- Five winners will receive \$2,500 cash and \$200 worth of scratch-offs.

## **OVERVIEW:**

Ten (10) participants in the Sizzling Summer Cash State Fair Promotion ("Promotion") will be randomly drawn as Winners. The Finalist and Runners-Up will be determined at the Event:

- Round 1: Winners of Round 1 Prizes announced.
  - Five: Cash & Scratch Winners \$2,500 in cash and \$200 worth of scratch-offs (will be eliminated from further play)
  - o Five: Remaining Winners will move on to Round 2
- Round 2: The five remaining Winners each receive a sealed envelope. The results of Round 2 will be inside the envelopes:
  - o Four: Runner-Up Winners
  - o One: Finalist Prize Winner
- Final Round:
  - The Finalist goes into the Cash Machine to grab as much cash as he/she can in 30 seconds.
  - o Runners-Up each win half the amount that the Finalist wins.

Winners must be present on Saturday, August 31, 2024 at the Event in order to receive cash prizes ("Event Prizes"). If any Winner is not present at the event, they will only receive the Prize (5 State Fair tickets and Parking pass).

**CLAIMING DATE:** Winner must contact the Lottery and submit all required documentation by 4:30 PM on Friday, August 16, 2024 or an alternate Winner ("Alternate") may be selected.

**ALTERNATE WINNER CLAIMING DATE:** Any Alternate must contact the Lottery and submit all required documentation by 4:30 PM on Friday, August 23, 2024. If an Alternate does not contact the Lottery and submit all required documentation by the claiming deadline, the Lottery, in its sole discretion will determine the outcome.

**EVENT DATE: Saturday, August 31, 2024** 

**EVENT LOCATION and TIME:** The Event will take place at the Maryland State Fairgrounds. A Lottery representative will provide Winners with exact time and location of Event upon notification.

**FINALIST REQUIREMENTS**: If you are the Finalist Winner and are not able to physically participate in the Cash Machine, you may designate a proxy to enter the Cash Machine in your place. All winners and proxy's must be at least 18 years of age.

**ESTIMATED TOTAL FINALIST PRIZE AND RUNNER'S-UP PRIZE VALUES:** Based upon amount won by the Finalist Winner in the Cash Machine.

ADDITIONAL RULES: You may submit as many entries as you like; however, you may only win once.

### **CLAIMING:**

You will be advised, at the time of notification, of claiming procedures, event procedures and reminded of claiming deadlines. Winners must present proof of your social security number and must furnish photo I.D. proof of being at least 18 years of age. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information including a signed waiver, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery.

If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then any cash portion of the prize will be applied first to those State obligations.

In the event of a winner's death or inability to partake of a prize, the Maryland Lottery will make a determination about the awarding of the prize. The Lottery's decision will be final.

You do not have the option to request or receive a substitute or equivalent prize for any prize.

The Maryland Lottery Customer Resource Center will process all cash prizes within 15 business days of the Event.

Winners will each receive a W-2G form from the Maryland Lottery. You will be taxed on the amount(s) won. All winners are responsible for all taxes, including income taxes.
