# Maryland Lottery ${ }^{\oplus}$ My Lottery Rewards ${ }^{\text {™ }}$ Mega Millions ${ }^{\circledR}$ Team USA ${ }^{\text {TM }}$ Second-Chance Promotion Drawing Rules 

## OVERVIEW:

Beginning any time on Monday, June 10, 2024, until 11:59:59 PM on Monday, August 12, 2024, ("Promotion Period") players can enter the Maryland Lottery ${ }^{\circledR}$ My Lottery Rewards ${ }^{\text {TM }}$ Mega Millions ${ }^{\circledR}$ Team USA ${ }^{\text {TM }}$ Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") for a chance to win a VIP trip for two (winner and one (1) guest) to either the 2026 Olympic Games in Milan, Italy, or the 2028 Olympic Games in Los Angeles, California, ("Trip Prize") as well as a Team USA ${ }^{\text {TM }}$ apparel and merchandise package ("Merchandise Pack"). The Maryland Lottery will conduct three (3) drawings ("Drawing(s)") to select a total of thirty-three (33) winners- of those selected, there will be thirty (30) Merchandise Pack winners and three (3) Trip Prize + Merchandise Pack winners

## HOW TO PARTICIPATE:

To participate, enter at mdlottery.com/rewards, or through the MLR App, both winning and nonwinning Mega Millions ${ }^{\circledR}$ tickets purchased during the Promotion Period. Players will have the opportunity to elect or refuse participation in this Promotion. Each Mega Millions ${ }^{\circledR}$ ticket entered into the program will trigger a pop-up on the website and app that will require the member to choose one of three (3) options: 1- to enter into the Promotion for the chance to win the Trip Prize and the Merchandise Pack, or 2- to enter into the Promotion for the chance to win the Merchandise Pack only, or 3- to decline entry into the Promotion. Each individual Mega Millions ${ }^{\circledR}$ ticket ("ticket") will gain the member one (1) entry into the Promotion when the member elects to participate. Additionally, each ticket entered will gain a member progress toward MLR Achievements whether or not they elect to participate in the Promotion.

Internet access and a valid email address are required to create a My Lottery Rewards account and enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like, and:

- You may only win one time per the entire Promotion; and
- Only one player per household/residence address (as registered with MLR at the time of the Drawing) is allowed to win per Drawing.
- To enter and to win, you must be 18 years of age or older.


## FOR EACH DRAWING:

Entries are non-cumulative, and will not carry over after each Drawing. Entries must be entered separately for the respective Drawing by 11:59:59 PM Eastern Time on the Drawing entry deadline date to be eligible for that Drawing. ## CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. (Players and winners are sometimes referred to as "you" and "your".) Claiming deadlines for winners, including Alternates, are included in the chart above.

- You do not need to keep your original ticket in order to claim your prize if you win.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including completing waivers for both the winner and the guest, and been confirmed and validated as eligible, then an Alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for Alternates. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to a prize.

## Merchandise Pack

Winners of the Merchandise Packs will be contacted by a Lottery representative via email, telephone and/or mail to confirm your mailing address and size for the hoodie. This prize will then be automatically fulfilled by EQL.

## Trip Prize

Winners ("Winners"; or, singular, "Winner") will select one of the two Olympic Games offered that they would like to attend as their prize.

- EQL will be responsible for coordinating all travel directly with the designated Winners and for providing and fulfilling all elements of the Trip Prize directly to the Winners.
- MLGCA will provide winners with the necessary tax forms, including a W-2G.
- As a further bonus prize, the Lottery will pay the required estimated State and Federal tax withholdings for this Trip Prize. Further amounts may be owed by the winner, and if so, such amounts shall be paid by the winner. The payment of tax withholdings could result in additional Federal and State tax liability being due for the winner. - Winners who choose to travel to the 2026 Winter Olympic Games in Milan, Italy, must have a valid passport. Winners who choose to travel to the 2028 Summer Olympic Games in Los Angeles, California, must have a valid US I.D.
- Winner and Guest must be at least eighteen (18) years old.
- Winner will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize.
- Travel and hotel accommodations are subject to availability.
- The date and location of any of the events or activities included in the Trip Prize ("Event(s)") may be subject to change. EQL is not responsible if any Event is delayed, postponed, or cancelled for any reason, in whole or in part, and in such event, the only obligation is to award the other elements of the Trip Prize.
- If the Trip Prize is cancelled for any reason outside of the Lottery's control, by the Olympics, EQL, or the Lottery, the Lottery will award the Trip Winners the cash equivalent of the estimated cost of the trip prize.
