

Maryland Lottery® My Lottery Rewards™ GAME OF THRONES™ Second-Chance Promotion Drawing Rules

OVERVIEW:

Beginning any time on Monday, September 23, 2024, until 11:59:59 PM on Monday, January 13, 2025, ("Promotion Period") players can enter the GAME OF THRONES™ Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Maryland Lottery" or "Lottery") through the Maryland Lottery® My Lottery Rewards™ for the chance to win one (1) of four (4) trips for two (2) to California's Napa Valley, to participate in THE SEVEN KINGDOMS EXPERIENCE Event ("Event") on or about November 2025 and win a share of up to \$7 million in cash prizes ("Trip Prize"). This Promotion will consist of four (4) drawings ("Drawings" or "Drawing"), and the Lottery will select one (1) winner of the Trip Prize during each drawing.

HOW TO PARTICIPATE:

Enter at mdlottery.com/gameofthrones or mdlottery.com/rewards or through the My Lottery Rewards ("MLR") App non-winning GAME OF THRONES™ Scratch-Off tickets and/or any other ticket specified by the Maryland Lottery purchased during the Promotion Period (each a "Ticket"). Each Ticket entered will generate a variable, pre-determined number of entries into the Promotion. Players may receive five (5), ten (10), fifteen (15), twenty (20), or twenty-five (25) entries per Ticket entered. The number of entries to which a ticket is entitled is random and pre-determined at the time of printing the ticket.

When a Ticket is entered into MLR, an animated interactive promotional game ("Promotional Game") will appear on the player's screen and reveal the number of entries the player will receive into the Promotion. Players may choose to bypass the Promotional Game and directly reveal the number of entries their Ticket will generate. A player's performance on the Promotional Game has no impact on the number of entries the player receives for each Ticket.

A Ticket may only be used once to enter the Promotion. Players will automatically receive progress toward MLR achievements as well as the variable, pre-determined number of entries into the Promotion for each Ticket entered.

Entries are not cumulative and will not carry over from each drawing to the next. Entries must be entered by 11:59:59 PM on its announced Drawing Entry Deadline date in order to be eligible for that Drawing. (In these Drawing Rules, all times are Eastern Time ("ET").) See the **Drawings Chart** below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline Date, Drawing Date, and Claiming Deadline Date for winners and alternates.

A Drawing may include any random selection event. This is a bonus drawing, and the Trip Prize is a bonus prize.

All winners, including alternate winners, must claim their prize by 4:30 PM EST on the respective claiming deadline. All entries received after the final Drawing Entry Deadline Date will be ineligible and void.

Entries received after the final Drawing entry deadline of 11:59:59 PM, January 13, 2025, will be ineligible and void.

Internet access and a valid email address are required for entry into the Promotion and its Drawings. Mailed entries will not be accepted. To enter and to win, players must be 18 years of age or older. Players may enter the Promotion as many times as they want, however, players may only win once during the entire Promotion; and, only one (1) winner per household/residence address (as registered with MLR at the time of the Drawing) is permitted per Drawing.

All winners' names and town/city of residence will be posted on the My Lottery Rewards Past Drawings & Winners page, and the Maryland Lottery Promotions page, and may be included in the Maryland Lottery's press releases, promotional emails, and/or social media posts.

PRIZE DESCTIPTION:

Each winner ("Prizewinner") will receive a trip for two (2) to Napa, California, to participate in the Event for a chance to win a shared cash prize of up to \$7 million (a "Cash Prize"). The five-day and four-night Trip Prize will take place on or around November 2025.

The Trip Prize will include:

- Roundtrip coach class airfare for up to two (2) people from a U.S. international airport to a San Francisco area international airport in California (inclusive of all associated security fees, taxes, and surcharges).
- Ground transfers coming and going between destination airport and the destination hotels and, if necessary, between events.
- One (1) double occupancy room accommodations (room and room tax only) at a 3-star or better hotel in Napa, California for three (3) nights.
- One (1) double occupancy room accommodations (room and room tax only) at a 3-star or better hotel in San Francisco, California for one (1) night.
- \$1,000 spending money for the Prizewinner to be provided two (2) weeks prior to the scheduled trip departure date.
- Admission for the Prizewinner and guest to the Welcome Reception.

- Prizewinner shall select from a variety of curated tours and activities in and around California's Napa Valley for Prizewinner and guest.
- Admission on the Napa Wine Train for Prizewinner and guest.
- Admission to Event venue for the Prizewinner and guest, and the Prizewinner, or duly
 authorized proxy, shall have one (1) chance to participate in the Event to win a shared prize
 ("Event Prize") from \$25,000 up to \$7 million as described below. The Prizewinner's guest may
 sit with the Prizewinner but will not be eligible to be a participant in the Event unless the guest
 has been appointed as the Prizewinner's proxy.

Estimated Trip Prize value, not including Event Prize: \$14,976.00, including tax withholdings.

The Trip Prize does **not** include: mileage, insurance, gratuities, meals, parking fees, baggage fees, alcoholic beverages, personal expenses such as telephone calls, valet service, laundry, incidentals and the like, revision or cancellation fees which may be charged by the hotel or other suppliers, or any other items not expressly specified herein.

The \$1,000 spending money will be awarded as a check and be mailed to the Prizewinner from Scientific Games, LLC ("SG") two (2) weeks prior to the commencement of his or her trip in the Prizewinner's final travel packet via signature required method. If the Prizewinner has debt set-off, the Prizewinner will receive the amount less the debt owed. If the debt owed exceeds \$1,000, the Prizewinner has the option to pay the debt or to forfeit the Trip Prize. The Lottery will then select an Alternate to replace the original Prizewinner.

The Prizewinner or guest must have a valid credit card or shall be required to post cash deposit for incidentals to check into the hotel. The Prizewinner and guest must be eighteen (18) years of age or older to participate in the Event, and the age requirement to check into a hotel in California is twenty-one (21), therefore the Prizewinner or guest must be twenty-one (21) years of age or older. Each Prizewinner and guest are subject to a background investigation, derived from public information, prior to the Event.

Prizewinner and guest shall be required to comply with the Department of Homeland Security's ("DHS") REAL ID Act and all other programs to attend the event. For more information, please see DHS's REAL ID webpage. If applicable, Prizewinner and guest shall be required to follow all health and safety protocols as instructed by the event's staff and volunteers and all federal, state, and local guidelines.

All Trip Prizes are not for resale and are not transferable. The Prizewinner may **not** choose to receive the cash equivalent of the trip portion of the Trip Prize.

THE SEVEN KINGDOMS EXPERIENCE EVENT DETAILS:

Overview: The Event shall be conducted according to Event and Security Procedures generated by SG and its third-party underwriters. Final Event details (the "Official Event Details") explaining how the Event will be conducted will be provide to the Maryland Lottery no later than sixty (60) days prior to the date of the Event.

The Maryland Lottery Prizewinners (or an assigned proxy) shall participate as a contestant in the Event together with winners from other participating lottery jurisdictions ("Contestants").

Each Contestant or assigned proxy will be randomly assigned to one (1) of seven (7) houses (each a "House" or plural, the "Houses") along with other Contestants. The number of Contestants in a House (a "House Member" or plural "House Members") to be determined based on lottery participation, but in the case of a Prize split (a "Prize Split"), or a total shared Prize value won, will be divided evenly by no more than sixteen (16) House Members per House, even if there ends up being more than sixteen (16) House Members in a House. A Prize Split will occur in Rounds #1 and #3.

The Event will consist of a Pre-Event Selection, immediately followed by three (3) rounds (each a "Round" or plural, "Rounds") as detailed below. Each Round will be played separately as follows:

<u>PRE-EVENT HOUSE RULER SELECTION:</u> Prior to the start of Round #1, one (1) House Member from each of the seven (7) Houses will be randomly selected, using a ball machine, as the House ruler (the "**House Ruler**" or plural, "**House Rulers**") to represent their House in the Event going forward.

<u>ROUND #1 JOUSTING TOURNAMENT:</u> Each House is randomly assigned a jouster for the chance to win a Cash Prize to be split evenly among members of each House. The Jousting Tournament will include three (3) Matches (each a "**Match**" or plural "**Matches**") as follows:

Match #1 – Quarterfinal: Before Match #1 begins, one (1) of the seven (7) Houses will be randomly assigned a tournament bye (the "House Bye") and will not be paired with another House for Event play, automatically advancing to Match #2 The remaining six (6) Houses will participate in Match #1. Three (3) Houses will be eliminated, with each awarded twenty-five thousand dollars (\$25,000) to be split evenly among the members of each eliminated House. The four (4) remaining Houses will advance to Match #2.

Match #2 – Semifinal: Four (4) Houses will participate in Match #2. Two (2) Houses will be eliminated, with each awarded one hundred thousand dollars (\$100,000) to be split evenly among the members of each eliminated House. The two (2) remaining Houses advance to Match #3.

Match #3 – Final: The two (2) remaining Houses will participate in Match #3. One (1) House will be eliminated and awarded two hundred and fifty thousand dollars (\$250,000) to be split evenly among the members of this eliminated House. One (1) House will be awarded one million dollars (\$1,000,000) to be split evenly among the members of this winning House and become the Finalist ("House Finalist Ruler") in Round #3.

*The Match pairings and Jousting Tournament Matches will be randomly selected outcomes, using an RNG, prior to the Event.

ROUND #2 DRAGON EGGS BONUS: Each of the seven (7) House Rulers will have the opportunity to win a Cash Prize Bonus from seven thousand dollars (\$7,000) up to seventy-seven thousand dollars (\$77,000) that will not be shared with their House. At the start of Round #2, the Event Host will call upon each Ruler in their randomly selected order, to select

one (1) of the fifteen (15) numbered dragon eggs (each a "Dragon Egg" or plural, "Dragon Eggs"). Each Ruler will win the individual Prize Bonus revealed in their Dragon Egg envelope and their Event play activity ends, with the exception of the House Finalist Ruler from Round #1 who will advance to Round #3.

ROUND #3 THE SPOILS OF WAR: The House Finalist Ruler from Round #1 will spin a wheel for the chance to win up to an additional six million dollars (\$6,000,000) for a total of seven million dollars (\$7,000,000) to be split evenly among members of the winning House in this Round.

Each Round will be played separately, and all Rounds will be audited by an independent auditor.

Contestants will be mailed the Official Event Details concerning the Event prior to their trip departure.

The Maryland Lottery shall have no liability for any Event Prizes.

The Event is being administered by Scientific Games, LLC ("SG"). Any questions regarding the Event, including questions regarding the assignment of proxies, prize payments, and tax liability or withholding for Prizes, should be directed to SG at 1-800-201-0108. Participation in the Event may be subject to other local, state, and federal laws, including the laws of the State of California.

CLAIMING:

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners and Alternates are included in the **Drawings Chart** above. Winners must claim their prize in person, unless specified by the Lottery upon notification, by **4:30 PM** of the claiming deadline date listed in the **Drawings Chart**, at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. The Trip Prize will be fulfilled by SG, once authorized by the Lottery.

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate may be selected. Alternates must claim by 4:30 PM on the claiming deadline designated for that Alternate. A decision to replace a winner is within the sole discretion and judgement of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the prize.

In the event of a winner's death of inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final. The Prizewinner may not choose to receive the cash equivalent of the trip portion of the Trip Prize.

SG will pay the required estimated State and Federal tax withholdings for the Trip Prize and the Event Prize, and the Prizewinner will be provided with a W-2G by January 31, 2026 for tax year 2025. Further amounts may be owed by the winner, and if so, such amount(s) shall be paid by the winner. The payment of tax withholdings could result in additional Federal and State tax liability being due for the

winner. All amounts paid to the Prizewinner on the Prizewinner's behalf will be included in the Prizewinner's reportable income. Prizewinner is responsible for all taxes, including income taxes in excess of withholdings paid by the SG.
